- 1 Their seniority in the cadre of L.D.C. will be regulated as per the EPF Staff (Fixation of Seniority) Regulations, 1989 as amended from time to time.
- 2 They can exercise their option for fixation of pay, if any, within one month from the date of their promotion.
- 3 They will have to pass typewriting speed test @25/30 per minutes in Hindi/English for drawal of annual increment in the cadre of L.D.C.
- 4 They will be on probation for a period of two years from the assumption of charge. Failure to complete the period of probation satisfactorily the same can be extended up to four years by the Competent Authority.
