The promotion is subject to following conditions:

1. Their seniority in the cadre of Section Supervisor will be regulated as per the EPF Staff (Fixation of Seniority) Regulations, 1989 as amended from time to time.
2. They can exercise their option for fixation of pay, if any, within one month from the date of their promotion.
3. Officials who are promoted in the cadre of SS on 27.12.2016 or after (i.e. from Sl. No. 9 to 20) are eligible for the Grade Pay Rs. 4600/- in the pay Band -2 i.e. Rs. 9300-34800.

The Promotions will take effect from the following dates:

- (i) In respect of officials at Sl. No. 1 to 6 & 8 to 11 who are already holding the post of SS, their date of promotion will be date of joining to the post of SS (Regular) earlier.
- (ii) In respect of Sl. No. 7 his date of promotion will effect from 01.11.2016 in place of 01.10.2016 as per recommendations of Review DPC held on 28.02.2017.
- (iii) In respect of Sl. No. 12 to 20 their promotion will effect from date of DPC or assumption of charge which ever is later.


